In 2019, Sandra testified before a bi-partisan Congressional committee (the "Helsinki Commission") as a national expert on stopping abuse of INTERPOL by autocratic nations. She has expertise in representing clients before U.S. consulates worldwide, with significant experience in administrative processing, and waivers of inadmissibility.

Sandra is a known litigator, successfully advocating for individuals before the immigration courts, the Board of Immigration Appeals, and in Federal District Courts. She also represents clients in deportation defense, detention and bond issues, the immigration consequences of criminal convictions, requests under the Freedom of Information Act (FOIA), asylum, and adjustment of status and naturalization applications, among other matters.

She is an active member of the American Immigration Lawyers Association (AILA) and serves on AILA's State Department Liaison Committee.
